# INFORMATION FOR PLAYERS SELECTED FOR ALL - COUNTY OR PRESIDENTIAL MATCHES

**ALL - MALE PLAYERS - MUST READ AND ABIDE BY THE FOLLOWING NOTES. FAILURE TO DO SO, MAY RESULT IN A PLAYER NO LONGER BEING CONSIDERED FOR SELECTION.**

**Female players IN MX MATCHES are governed by the Dress Code and Regulations of the Women's Section.**

## **ACTIONS PRIOR THE MATCH DAY**

- a) **ALL MALE PLAYERS - must make a note of the Contact number for the Match Official, for use if a problem on the day. Any problems - or expected later arrival - MUST BE phoned to one of the two contact numbers on the team sheet.**
- b) Requests for any Guest or Dietary Meals must be notified at least seven days prior to the fixture and cannot be guaranteed, if such notice is not given. **Guest meals will be at the meal cost as charge by the host Club.**

**NB: Any player who books a meal for a guest and then does not bring that guest will still be required to pay for that meal. The host club is notified 5 days in advance of numbers for catering.**

- c) **Mens Section Rules - Rule 4c will apply to any player who fails to turn up.**

## **ARRIVAL, DRESS REQUIREMENTS AND MOBILE PHONES**

- a) **ALL male players are required TO ARRIVE AT LEAST 30 MINUTES prior to the start time and ON ARRIVAL THEY MUST IMMEDIATELY REPORT IN - and pay their match fee - TO THE MATCH OFFICIAL.**
  - (i) For ALL County and Presidential matches - all players may travel and arrive - **in either:**
    - a) Grey trousers and a white shirt - OR;
    - b) Their playing gear, which comprises of NEW County Blue Trousers or Shorts, New County Shirt and plain White socks. Shirts are designed to be worn outside of trousers and therefore **should preferably - not be 'tucked into trousers'**.
    - c) Dress for all matches is as detailed above, unless notified otherwise. A Blazer - IS OPTIONAL - but is to be worn by the President and the Match Official. Bowls shoes must not be worn for arrival but proprietary bowls shoes must be changed into - at the green - to avoid bringing any contamination to the green.
- b) Jumpers, Fleece/Zippers/Hats/Caps MUST BE White or approved County merchandise. If you are unable to comply with the dress code, contact the County Secretary - in advance of the match date.
- c) All players must use blue County Stickers on their woods - unless advised otherwise by the Match Official.
- d) Under NO CIRCUMSTANCES are Mobile phones to be used on or around the green during a match. Any player who smokes - including e-cigarettes - MUST use areas designated by the host club.

## **POST MATCH**

- a) Players ARE EXPECTED to remain for the after Match Meal (even when games are cancelled after arrival). Any player who - **in exceptional circumstances only** - is unable to remain for the after match meal, MUST notify reasons to the Match Official as early as possible but will still pay the full match fee.
- b) After the match players, may either remain in their playing gear or change into Grey trousers and White Shirt, for the after match meal. All player who travel in playing kit, MUST carry Grey trousers and a white shirt, or spare playing kit, to change into for the meal - if their playing kit gets wet.
- c) **Score Cards are to be handed to the Match Official - or placed on his table - on completing of the match - and prior to taking any other actions.**

**If players wish to arrange joint travel, selectors have contact details for all players selected which they can supply if required.**

**Area Selectors are to notify the Match Secretary or Hon. Secretary, details of any guests requiring a meal, any dietary requirements, or any players unable to remain for the meal after the match - and to notify the Hon Secretary of any Trousers/Shorts/Shirt requirement.**
